TERMS OF REFERENCE

Committee Name: Airport Master Plan Technical Advisory Committee (ATAC)

1.0 Committee Mandate

The mandate of the Airport Master Plan Technical Advisory Committee (ATAC) is to provide advice and feedback to the City of Vernon during the development of the Master Plan. The ATAC is not a decision making group.

2.0 Purpose

- **2.1** Provide feedback on key issues during the Airport Master Plan.
- **2.2** Assist with consultation activities and review of the results.
- **2.3** Review and provide feedback regarding Master Plan proposal development concepts and alternatives.
- **2.4** Review and provide feedback on the draft Master Plan and associated studies and documents.
- **2.5** Advise on other related issues, as needed.

3.0 Membership

- **3.1** The ATAC membership is appointed by the Airport Master Plan Staff Advisory Committee.
- 3.2 The ATAC is comprised of a maximum of twelve (12) representatives from key airport stakeholders, the aviation industry, lease holders at the airport and local business. The representatives will be selected to represent one or more of the following sectors. Not all sectors may be represented and Staff Advisory Committee may appoint more than one representative from an individual sector.

a) Corporate Aviation

b) Aviation Education

c) Private Aviation

d) Aviation Tourism

e) Aviation Related Industry

f) Aviation Professionals

g) Recreational Aviation

h) Land Use Development

i) Commercial Air Services

i) Aviation Related Businesses

 - a) Airport Master Plan project manager
 - b) Vernon Regional Airport Manager
 - c) Manager, Long Range Planning and Sustainability
 - d) Economic Development Planner

- **4.2** The ATAC will meet as needed based on the completion of project stages, as outlined in Council Report titled Airport Master Plan Planning Process Proposal, dated October 20, 2014.
