# **GENERAL MATTERS**

DELEGATION – NORTH OKANAGAN CYCLING SOCIETY – YOUTH PROGRAMS AND DEVELOPMENT COMMITTEE (6520-25) Nicole Robert, Youth Programs Director, Ed Jule, Crystal Townsend, Coach and youth members of the North Okanagan Cycling Society (NOCS), presented to Council about inclusion of a mountain bike skills area as part of the Kin Race Track Development Plans.

The following points were noted:

- A new bike park compliments next skills track from Becker Park
- Fits in well with other ideas for the Kin Race Track site
- Biking is one of the fastest growing sports, NOCS grew by 500 members last year, expectations are growth of 10% a year
- More biking facilities needed in Vernon
- · Examples of bike parks in other towns reviewed
- Would like similar facilities to other towns including a paid pump track with dirt jumps
- Encourage youth from building their own
- Biking tracks develop bike skills in youth
- The petition (included in the Council agenda package) was highlighted
- Youth Members from NOCS spoke highlighting:
  - Their love of riding
  - New track would increase their ability to compete by improving biking skills
  - Most towns have pump tracks and this allows youth to compete in various competitions
  - New park would be fun and beneficial and would allow youth to be involved in environmental issues and trail building
  - Currently nowhere in Vernon to improve skills
- Dirt jumps are cheaper to install than a grass field
- Requests that Council consider progressive dirt jumps and a pump track on Kin Race Track lands
- Respectfully request inclusion of a pump track at Kin Race Track.
