Councillor Guy provided the following update on City Council business:

September 25, 2023 – Committee of the Whole Meeting

- BC Transit service expansion initiative for the next three years*, including:
 - New Route 10 (Middleton Mountain),
 - Statutory holiday service on routes 1-9,
 - handyDART expansion to provide Sunday and statutory holiday service; and
 - Weekday service improvements on routes 3, 5 and 9.

*These service expansions start in September, 2024.

October 10, 2023 – Regular Council Meeting

- ZON00395 – 3350 Okanagan Avenue: This will be a 25 lot subdivision. Every unit will be EV-ready and suite-ready. Also, each unit will be solar-ready, meaning a conduit will be installed from the basement into the attic large enough to contain both wiring for future rooftop solar panels and hot water tubing for a future rooftop solar hot water system.

October 23, 2023 – Regular Council Meeting

- Bruce Mol from Ribbons of Green Trails Society made a presentation on cycling routes in the city. He emphasized the importance of separated cycling lanes and links between route networks. This presentation will be valuable for the update to the Master Transportation Plan coming soon.

- The fall Go by Bike Week results: 327 riders, 56 teams, 20 new riders, 16,606KM traveled, 1350 trips, and 3600 KGs of GHG savings.
