**A Bylaw:**

To amend Zoning Bylaw #5000 to address hobby urban beekeeping in the City of Vernon.

**A Bylaw:**

To rezone the subject properties from residential to light industrial and commercial and to vary sections of Zoning Bylaw #5000 to develop a three phase light industrial and commercial business park (*Silver Star Gateway Business Park*) at 4800, 4808, 4816, 4824, 4940, 5012 Silver Star Road;

AND,

To vary sections of #5000 to allow for an industrial development to be constructed on Lot 3, Plan KAP90756, Sec 2, Twp 8, ODYD (5012, 4940, 4824 Silver Star Road).

- c) Mayor will call for representation from the public in attendance.

  - ii. The Chair will recognize ONLY speakers at the microphones. Speakers may be requested to limit the length of time they speak until all present, who wish to be heard, have been given an opportunity. Thereafter speakers may take another opportunity to speak.
  - iii. The public and members of Council may ask questions of the applicant and / or City staff in order to clarify details of the project, etc.
  - iv. Final calls for representation
