Rates: Rates may be adjusted for ongoing rentals. Tax included.

Cleaning:

In addition to the rental rates there are cleaning fees. All renters are required to return the facility to the condition that they found it in. After rentals we still need to bring our caretaker in to go through the facility washrooms, kitchen, windows, and do another cleaning and disinfect, etc.

Smaller events: \$34.40 - 25 attendees or less Medium Event: \$68.80 - 26-50 attendees

Larger events (weddings, etc.) \$137.59 - 51+ attendees

Hours

Because of our location with neighbours we have had to restrict events to 10:00pm. All music and alcohol must be ended at 10:00pm with clean up to follow and out of building by 11:00pm.

What's Included:

120 chairs are stocked at the facility and can bring more if needed.

Tables on-site: two - 4' tables | four - 6' tables | four - 8' tables | twelve - 5 'round tables

Podium on site.

No AV equipment available.

Set Up and Take Down:

The renter is responsible for all set up and take down; everything must be cleaned off and put away at the end of rental.

Kitchen:

The kitchen is included with all rentals (no dishes or utensils):

-warming oven -three prep tables -small freezer -commercial dishwasher (1 rack at a time)

-domestic oven -two large sinks -hand washing sink -double door commercial cooler

Washrooms:

Men's, Women's and Universal Washrooms.

Insurance:

Two million third party liability insurance is required for all events. The City of Vernon must be named as the co-insured on the certificate. If alcohol is being served there would have to be host liquor liability coverage.

Liquor License:

We require a copy of the liquor license you apply for.

Booking Deposit:

A \$100 non-refundable booking deposit is required at the time of signing the Facility Use Permit.

Damage Deposit:

A \$500 Damage Deposit is required to paid by credit card prior to event. This can be paid when picking up the key for the building the day before the event and will be credited back when the key is returned and caretaker has reported back.

Caretaker:

There is a local caretaker for the facility and we can arrange viewings.
